#### Statement of intent

Our intention is that all pupils, irrespective of their background or the challenges they face, make good progress and achieve high attainment across all subject areas. The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers.

#### **Objectives in spending PPG:**

- To ensure the learning needs of all pupil premium pupils are being addressed through daily intervention and quality first support within classroom teaching and that emotional support is available where necessary.
- To provide 1:1 or small group tutoring sessions to pupil premium pupils to facilitate curriculum catch-up.
- To provide ongoing emotional support for vulnerable pupils with an ELSA on site at all times.
- To continue to provide high-quality reading materials for disadvantaged pupils to keep in their homes.
- To enable disadvantaged children to attend school trips.
- To enable disadvantaged pupils to participate in before and after school clubs and wrap-around care.

#### Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

1	Assessments, observations, and discussions with pupils indicate underdeveloped oral language skills and vocabulary gaps among some of our disadvantaged pupils.
2	The support of 1 pupil who have travelled from the Ukraine to continue to access their education and begin to catch-up academically with their peers.
3	Data indicates that three pupils are currently working below the expected standard in maths.
4	Data indicates that three pupils are below the expected standard in reading.
5	Data indicates that six pupils are below the expected standard in writing.
6	Data indicates that one pupil made less than the expected progress in maths and reading by the end of Key Stage 1.

7	Our assessments (including wellbeing survey), observations and discus- sions with pupils and families have identified social and emotional is- sues for many pupils and a lack of enrichment opportunities during school closure. These challenges particularly affect disadvantaged pu- pils, including their attainment.
	Teacher referrals for ELSA support have markedly increased during the pandemic. 5 pupils currently require additional support with social and emotional needs through attendance at small group or 1:1 ELSA sessions.

# Part B: Review of outcomes in the previous academic year

#### Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2021 to 2022 academic year.

Performance measures have not yet been published for 2022 to 2023.

Evaluation of the 2022-2023 Intended Outcome Success Criteria:

 To ensure the learning needs of all pupil premium pupils are being addressed through daily intervention and quality first support within the classroom teaching and emotional support is available where necessary.
 91% of pupil premium pupils made at least the expected progress in maths and reading during the year 2022-2023, with 100% making at least the expected progress in writing.
 Some pupils have been identified as working below the expected standard in English and writing and reducing this gap will be a focus for academic year 2023-2024.
 Pupils A and B will access their year groups curriculums and show expected levels of academic progress by June 2023.

Pupil A did not show a good level of development against the EYFS curriculum, although he achieved the expected standard in some areas.Pupil B has been able to access the relevant year group curriculum and has demonstrated accelerated progress in reading, writing and maths during the

2022-2023 academic year.

3. Pupil A will be working at expected standard in English and maths by July 2023. This pupil received weekly 1:1 or small group tuition and had regular access to LSA support and ELSA guidance. By the end of the 2022-2023 academic year, they were working at the expected standard in reading but were below the expected standard in writing and maths.

Pupils B and C will be working at expected standard in English by May 2023. By the end of the academic year, one of these pupils was working at the expected standard in English and maths. The other pupil was working at the expected standard in maths, but was below the expected standard in reading and writing.

 To provide ongoing emotional support for vulnerable pupils with an ELSA on site at all times.

Four pupil premium pupils have accessed regular ELSA support over the academic year 2022-2023.
